Dear DGSRC Member:

Thank you for your patience as the DGSRC Board works through the details of our "2020 Safe Facility Operating Plan" for the upcoming club season. As you can imagine, all nine volunteer DGSRC Board Members have been working extraordinarily hard on behalf of all of our club members on how to adapt to our current circumstances and to make the best of an unfortunate situation. Many members have expressed the dire need for some sense of normalcy for the summer, and we hope to provide a safe environment for our members to do so, but we need your help.

Based on CDC guidelines and the DGSRC Membership survey findings (see attached), DGSRC will install the following "2020 Safe Facility Plan Opening" operational guidelines. Again, joining the pool is a personal decision you will need to make on behalf of you and/or your family. The DGSRC Board is not here to offer guidance to our members regarding the risks of visiting the facilities this summer. Therefore, if you are not comfortable with our operating procedures noted below, the DGSRC is offering the following refund options.

We would be remiss if we did not mention the financial realities of the Club and our long-term viability. As a community staple for the last 61 years, we certainly want to honor the refund requests from our members. At the same time, please keep in mind that our fixed expenses will remain the same this year, and our goal is to be around for many more years for the local community to enjoy.

Members that would like a refund based on our "2020 Safe Facility Plan Opening" guidelines due to health considerations or other concerns can:

1. Request a full membership refund for the 2020 season by emailing membership@dgsrc.net.
2. Guarantee a 2021 summer membership with 2020 refund less the \$95 initiation fee (which would alternatively be incurred as 2021 as a new member) by emailing membership@dgsrc.net.
3. Request membership credited to the 2021 season by emailing membership@dgsrc.net.

Important! All refunds must be requested by June 1, 2020 so we can appropriately plan for the summer for our 2020 club members. All 2019 members must renew by June 1, 2020 or be considered new members when renewing at a future date.

Finally, we have been in contact with the DuPage County Department of Public Health, Illinois Department of Public Health, Office for Economic and Community Development, the Mayor's office as well as the Governor's Office. We still have no current direction available for private pool facilities at this time not to mention that the DuPage County Health Department extended the club's current permit until June 30th, but renewal information has not been released as of yet. We thank you in advance for taking the time to read our "2020 Safe Facility Operating Plan" and agreeing to these guidelines as a club member that we will enforce this summer to create a safe environment for our members and employees.
